



Swisse Sleep Consumer Promotion

Terms and Conditions of Entry

1. Promoter

The Promoter is Swisse Wellness Pty Ltd (ABN 62 004 926 005) of Level 7, 88 Langridge Street, Collingwood VIC 3066 Australia (**Promoter**).

Promotion period

The Promotion will commence at 09:00 AEDT on 28.07.2023 and conclude at 23:59 AEDT on 30.09.2023 (**Promotion Period**).

2. Who can enter

Entry into the Promotion is only open to Australian residents aged 16 years or over, excluding:

- (a) management, employees, directors and contractors of the Promoter, its related entities and other agencies, firms or companies associated with the Promotion (including suppliers of the prize);
- (b) a spouse, de-facto spouse, parent, guardian, child or sibling of a person referred to in paragraph (a) of these Conditions of Entry;
- (c) persons who have breached the terms and conditions of any promotion run by or on behalf of the Promoter,

(**Eligible Entrants**).

The Promoter is responsible for determining whether a person is an Eligible Entrant in its absolute discretion.

Entrants under 18 years of age must have a parent or guardian's permission before providing personal information and entering the Promotion.

Any entrant who, in the opinion of the Promoter:

- (a) tampers or interferes with the entry or draw mechanism in any way;
 - (b) engages in any unlawful or improper conduct which jeopardises, or is likely to jeopardise, the fair or proper conduct of the Promotion; or
 - (c) who does not properly comply with the entry process; or
 - (d) engages in any unlawful or improper conduct during the fulfilment of the Prize;
- will be ineligible to win.

3. How to enter

To enter and be eligible to win, Eligible Entrants must, during the Promotion Period:

- (a) purchase any Swisse product(s) online from swisse.com.au or from an authorised Swisse retailer* in Australia (Qualifying Purchase) and retain their original purchase receipt;
- (b) visit www.swisse.com.au/sleep-competition (**Online Entry Site**); and
- (c) fully complete and submit the online Promotion entry form on the Online Entry Site (**Online Entry Form**), including:
 - i. all details required on the Online Entry Form, including but not limited to their first name, surname, email, mobile number, post code, authorised retailer;
 - ii. the last four (4) digits of the receipt number corresponding to their Qualifying Purchase; and
 - iii. their acceptance of these Terms and Conditions of Entry

(**Eligible Entry**).

Each Qualifying Purchase entitles an Eligible Entrant to one entry into the Promotion. Eligible Entrants may enter the Promotion multiple times, provided they have made multiple Qualifying Purchases and have a unique purchase receipt for each Qualifying Purchase.

The Promoter reserves the right to allow additional retailers to participate in the Promotion at any time and revise the list of participating retailers in Schedule 1 accordingly.

4. Prize information and draw

Five (5) potential winners will be drawn via a random electronic draw at Level 7, 88 Langridge Street, Collingwood, Victoria 3066 Australia at 11am AEDT on 02.10.2023 and the Prize will be awarded to the first five (5) Eligible Entries drawn following winner validation and verification (**Winners**).

The Promoter may draw additional reserve entries (and record them in the order that they are drawn) in case an invalid entry or ineligible entrant is drawn.

The Winners will each win a QT Hotels and Resorts gift card valued at \$2000 which will be emailed to the winners (**Prize**).

The total Prize pool value is \$10,000 (inclusive of GST). Utilisation of the Prize is subject to the QT Hotels & Resorts Pty Ltd gift card terms (<https://www.qthotels.com/gift-cards/terms>).

Prize can be used for full or part payment for accommodation, experiences, food and beverage and any other hotel services at QT Hotels & Resorts in Australia.

Prize must be redeemed within 36 months of the gift card issue date. Winners will be required to present their credit card at time of accommodation check-in.

The Prize is not transferable or exchangeable and cannot be taken as cash. The Prize must be taken as offered and may not be varied.

The draw result is final and no correspondence will be entered into.

5. Notification of Winners

Winners will be notified via email within one (1) business day of the draw and their last name, initial of their first name and postcode will be published on www.swisse.com.au/sleep-competition from 02.10.2023 for a period of 30 days. All reasonable efforts will be taken to contact the winner. The Promoter takes no responsibility for unread, undelivered or incorrectly provided email information.

6. Unclaimed prize draw

If a Winner cannot be contacted and a Prize remains unclaimed at 5pm (AEDT) on 05.11.2023 a replacement Winner will be chosen from the reserve entries. If there are no available reserve entries, a random electronic re-draw will be conducted at Level 7, 88 Langridge Street, Collingwood, Victoria 3066 Australia at 11am AEDT on 06.11.2023 by the Promoter from all remaining entries received in the Promotion, subject to any directions from the relevant state and/or territory gaming departments (**Re-Draw**). Any Re-Draw winner will be notified by phone and email within one (1) business day of the Re-Draw and their last name, initial of their first name and postcode published on www.swisse.com.au/sleep-competition from 06.11.2023 for a period of 30 days.

7. Winner Verification

Eligible Entrants must retain their original purchase receipt from their Qualifying Purchase (**Proof of Purchase**) which corresponds to each entry they submit in the Promotion.

If requested by the Promoter, Eligible Entrants must produce, within the time requested by the Promoter at its absolute discretion:

- (a) appropriate photo identification or other documentation, required by the Promoter to verify their identity, age, eligibility to enter the Promotion and claim the prize (if won) and compliance with these Terms and Conditions of Entry; and
- (b) their original purchase receipt (or other acceptable proof of purchase acceptable to the Promoter) that corresponds to all entries they have submitted in the Promotion.

If the items required by the Promoter are not received or an entrant has not been verified to the satisfaction of the Promoter within the time period required by the Promoter, the entry(s) submitted by the entrant will be deemed invalid.

The Prize will only be awarded following all validation and verification requirements of the Promoter being met to its satisfaction. In the event that an Eligible Entrant cannot provide suitable validation or verification, the Eligible Entrant will forfeit their right to a Prize and no substitute will be offered.

8. Prize delivery

Once the Winners have been verified and validated, the Prize (in the form of a QT Hotels & Resorts gift card) will be emailed to the Winners.

If a Winner is under the age of 18, the Prize will be awarded to the Winner's nominated parent or legal guardian.

The Prize must be redeemed within any redemption dates, subject to availability and any blackout periods, specified by the prize supplier, QT Hotels & Resorts.

If the Prize is no longer available, the Promoter may substitute with a prize of equal or higher value (subject to any written directions from a regulatory authority).

The Promoter accepts no responsibility for any entries not received for any reason during the Promotion Period. The Promoter does not warrant that the entry mechanism will be available at all times during the Promotion Period.

- (a) Promoter, the Promoter's related entities and any agencies associated with the Promotion, and
- (b) the employees, agents, directors and contractors of all entities referred to in paragraph (a),

shall not be liable for any loss or claim, action, demand, liability, damage, cost, expense or personal injury whatsoever (including but not limited to any direct, indirect or consequential loss), incurred, suffered or sustained by any person or entity (without limitation) in connection with, or arising from, the Promotion or the acceptance or use of the Prize, except that which cannot be excluded by law (in which case that liability is limited to the maximum extent allowable by law).
